Year 12 Applied Criminology

Dear Families

I am getting in touch with the details for the Criminology Unit 1 controlled assessment re-sit, which will take place on Friday 20 (periods 3-5) and Monday 23 June 2025 (all day). Your Year 12 student has chosen to re-sit because they want to aim for a higher mark, or because their unmoderated mark for their first attempt may not achieve a pass this summer.

As you will be aware, Level 3 Applied Criminology is a vocational course and students are required to pass all four units in order to gain the Diploma in Applied Criminology in year 13. Students are allowed one resit attempt for this unit; the higher of their two marks will go towards their final award in summer 2026. Please be aware that their re-sit mark will be entered next year, so it will not show on their results slip that will be issued on Thursday 14 August 2025.

Arrangements for the re-sit will be the same as they were in January, with the exception that:

- Students will be given a different unseen brief to work with during the assessment
- Students have had individual feedback on their first attempt and have had time to improve their folders, to give them the best chance of success

As before, the assessment will take place in a school computer room over two days (venue TBC). This is a written (typed) assessment, completed independently in exam conditions, for which students will have access to their unit 1-folder notes (subject to advance approval of the contents). Full details are below. Students who qualify for extra time will receive this automatically at the end of each session.

Attendance and punctuality is compulsory on <u>both days</u> of the controlled assessment - this re-sit cannot be rearranged. Any genuinely unavoidable absence due to serious illness must be communicated to the school by a parent/carer (by contacting both myself and <u>ks5absence@sackvilleschool.org.uk</u>), and must be supported by a Doctor's note (as is the case for external exams).

In preparing their unit 1 folders for the re-sit, students have been reminded to ensure that their notes are 100% their own work, with no use of AI and no plagiarism from the textbook, websites, or other students. Plagiarism or use of AI in the controlled assessment will be reported to the exam board as malpractice.

The students know that their unit 1 folders must be handed in for checking by **3pm on Monday 16 June 2025**; failure to meet this deadline may mean that they cannot complete the re-sit. The folder must be handed in to me in person and should not be left in the classroom.
