## Year 7 Curriculum Enhancement Week from Monday 13<sup>th</sup> July – Thursday 16<sup>th</sup> July 2020

You may be aware that each year at the end of the summer term Sackville suspends the normal timetable for four days for an 'activities week' that we call Curriculum Enhancement Week.

We are writing at this early stage as students need to choose between Blackland Farm or Ardingly Watersports as their outdoor and adventurous activity day.

At Blackland Farm students will take part in four activities. Three will be high-rope type activities, and one will be problem solving. You are invited to make a voluntary contribution of £45.00 for the day at Blackland.

Ardingly Watersports is based on the reservoir at Ardingly. There will also be four activities, with students being able to have a go at sailing, kayaking, windsurfing, raft building and racing. You are invited to make a voluntary contribution of £57.50 for the day at Ardingly.

Please be aware that as the school could not bear the cost of the visit, the visit will not take place unless parents, who are able to, are willing to contribute. There will be no other charges for any of the activities during the week. Insurance for all school trips is arranged through West Sussex County Council. Full details of the policy can be found on our website at http://www.sackville.w-sussex.sch.uk/?page\_id=26728. Peanuts or peanut related products are not allowed to be taken on any school visit.

Please remember that if your child is eligible for the Pupil Premium government grant we can use that to pay for the full cost of Curriculum Enhancement Week. All you need to do is tick the consent box on the online payment system. If, however, you would like to make a contribution towards the Curriculum Enhancement Week there is also a facility to make payment.













Please could you complete and return the slip below by Friday  $10^{th}$  January 2020, indicating which of the two activities you wish your child to enjoy. If either activity is oversubscribed, then students will be entered into a ballot with priority being given to those who did not take part in that activity last year. At this stage we will be asking for a £20.00 deposit, to be paid via the online payment system.

Once we know the result of the ballot the remainder can be paid in full.
